Privacy Policy

The Send Prayer is a non-profit project and can be used free and commercial free. The person responsible for processing the personal data we process is the owner of Neyens, a company operating under the name Brandbrewery. Our contact information is:

This app is developed by Neyens based in Norway (org. No. 927 506 041) in collaboration with The Send Prayer – a working group connected to The Send responsible for this follow up program. Neyens operates under the name Brandbrewery. as a free follow up of The Send. Through this app we seek to guide the participants into a living, sustainable prayer life.

The App provides weekly podcast introduced by a blog post. Users can post comments on the podcasts to create further interaction. Posts and podcasts can be downloaded to be read or listened on a later moment. In addition, users can find recourses to help their devotional life, relevant events, and locations where they can meet others who are seeking to grow in their relationship with God. We use push notifications to inform people about new content. People are free to turn off these notifications. The app uses geolocations to invite people though push notifications to events close to them, this is not mandatory. People are asked to sign in with their email address, this gives us the possibility to know who are actively using the app. It gives us the possibility to adapt our content and push notification to this active group. This is not mandatory.

Collection of personal information and geolocation

Among the types of Personal Data that this Application collects, by itself or through third parties, there are: Cookie and Usage Data.

Sign up and profile

Users are asked to sign in using their email address and a password. When making a

profile users can choose to add location, description, profile picture. This personal information is not mandatory to use the app.

Content commenting

Depending on the settings chosen by the Owner, Users may also leave anonymous comments. If there is an email address among the Personal Data provided by the User, it may be used to send notifications of comments on the same content. Users are responsible for the content of their own comments.

Geolocation

Users are asked to allow geolocation to run on the background also when the app is not in use, this is not mandatory.

About the personal data

The Personal Data may be freely provided by the User or collected automatically when using this Application.

Cookies and other tracking tools

Any use of Cookies - or of other tracking tools - by this Application or by the owners of third-party services used by this Application, unless stated otherwise, serves to identify Users, and remember their preferences, for the sole purpose of providing the service required by the User. Failure to provide certain Personal Data may make it impossible for this Application to provide all of its services.

Why data is gathered

Sign up and profile

Personal data, email address, location and description help us to provide relevant content and a better understanding of our target group. This is all aimed at improving the user's experience.

Content commenting

A username and email address needed to place a comment. This, to make it possible to respond to comments and in this way improve the user's experience.

Geolocation

Geolocation is used to send invitations to events in the form of a push notification to people who are close to the event.

Mode and place of processing the Data

Methods of processing

The Data Controller processes the Data of Users in a proper manner and shall take appropriate security measures to prevent unauthorized access, disclosure, modification, or unauthorized destruction of the Data.

The Data processing is carried out using computers and/or IT enabled tools, following organizational procedures and modes strictly related to the purposes indicated. In addition to the Data Controller, in some cases, the Data may be accessible to certain types of persons in charge, involved with the operation of the site (administration, sales, marketing, legal, system administration) or external parties (such as third-party technical service providers, mail carriers, hosting providers, IT companies, communications agencies) appointed, if necessary, as Data Processors by the Owner. The updated list of these parties may be requested from the Data Controller at any time.

Place

The Data is processed at the Data Controller's operating offices and in any other places where the parties involved with the processing are located. For further information, please contact the Data Controller.

Retention time

The Data is kept for the time necessary to provide the service requested by the User, or stated by the purposes outlined in this document, and the User can always request that the Data Controller suspend or remove the data.

The use of the collected Data

The Data concerning the User is collected to allow the Application to provide its services, as well as for the following purposes: Access to third party services' accounts, Creation of the user in app profile, Content commenting and Interaction with external social networks and platforms.

The Personal Data used for each purpose is outlined in the specific sections of this document.

Additional information about Data collection and processing

Legal action

The User's Personal Data may be used for legal purposes by the Data Controller, in Court or in the stages leading to possible legal action arising from improper use of this Application or the related services. The User is aware of the fact that the Data Controller may be required to reveal personal data upon request of public authorities.

Additional information about User's Personal Data

In addition to the information contained in this privacy policy, this Application may provide the User with additional and contextual information concerning particular services or the collection and processing of Personal Data upon request.

System Logs and Maintenance

For operation and maintenance purposes, this Application and any third party services may collect files that record interaction with this Application (System Logs) or use for this purpose other Personal Data (such as IP Address).

Information not contained in this policy

More details concerning the collection or processing of Personal Data may be requested from the Data Controller at any time. Please see the contact information at the beginning of this document.

The rights of Users

Users have the right, at any time, to know whether their Personal Data has been stored and can consult the Data Controller to learn about their contents and origin, to verify their accuracy or to ask for them to be supplemented, cancelled, updated or corrected, or for their transformation into anonymous format or to block any data held in violation of the law, as well as to oppose their treatment for any and all legitimate reasons. Changes to this privacy policy

The Data Controller reserves the right to make changes to this privacy policy at any time by giving notice to its Users on this page. It is strongly recommended to check this page often, referring to the date of the last modification listed at the bottom. If a User objects to any of the changes to the Policy, the User must cease using this Application and can request that the Data Controller erase the Personal Data. Unless stated otherwise, the then-current privacy policy applies to all Personal Data the Data Controller has about Users.

Information from the use of our applications

When you use our mobile apps, we may collect certain information in addition to information described elsewhere in this Policy. For example, we may collect

information about the type of device and operating system you use. We may ask you if you want to receive push notifications about activity in your account. If you have opted into these notifications and no longer want to receive them, you may turn them off through your operating system. We may ask for, access or track location-based information from your mobile device so that you can test location-based features offered by the Services or to receive targeted push notifications based on your location. If you have opted in to share those location-based information, and no longer want to share them, you may turn sharing off through your operating system. We may use mobile analytics software (such as crashlytics.com) to better understand how people use our application.
